

Results of the statement of our member of parliament on a theme: "Civil law"

To define a position of our choice, people have been divided into 3 groups showing interest to forthcoming elections.

In our parliament more activity was shown by a party **National Democratic Party of Tajikistan (NDPT)**. Their opinion is: currently there are such problems in our Republic as infringement of the rights of each person, especially children:

What rights of people are broken in our Republic?

1. Receiving information about our health;
2. Receiving medical aid;
3. The right to create family;
4. The right with whom to create family;
5. The right to get an education;
6. Violence over people, particularly, over women and children.

Are these problems actual in our Republic?

During carrying out of discussions on the questions given below, other fraction nominating the nominee - **Communist party of Tajikistan (KPT)** has joined to party **NDPT**. Representatives of both parties were agreeing in summarizing of results in urgency and importance of the problems, existing in Tajikistan.

The statistics of Republic Tajikistan shows, that all these problems are actual in Republic including other countries. In order to solve all these problems is required cooperation between many Ministries and NGO's. If today it will not be possible to solve or even to settle quantity of infringements of human rights, it will be difficult to establish healthy and democratic country.

Consideration about above specified rights:

Nowadays the majority of teenagers can not get information about health including **IPPP, VICH/SPID** that adults do not allow or do not approve the access of youth for such kind of information.

Besides, there are broken human rights in creation of families on the wish and choice of youth in our Republic. To these problems are related other problems like violence, absence of high-grade formation (girls, girls), and reception of medical aid.

The reasons infringement of these rights:

1. Ignorance
2. Mistrust;
3. Financial need;
4. Not knowledge;
5. Family customs;

6. Influence a society;
7. Influence of war;
8. Overestimate of official powers

The ways of decision these problems:

1. Carrying out of information-educational debatable meetings with parents, with youth, with teachers and authorities;
2. Carrying out of the actions concerning human rights;
3. Prohibition of creation of family without the consent and without human rights of partners;
4. Improvement of a standard living of people.

Other representatives of parties disputably approached to decisions of a problem, therefore under the consent of our parliament we have decided to bring in only opinion of two representatives of parties (**NDPT, KPT**) and to deduce their result debat.

Taking into account growth of our population the first, that we should make it to restore strong system in all branches, in particular in the field of civil law. Where we were also what field of activity did not mention, everywhere it is possible will collide the right infringement of citizens though we live in the independent democratic sovereign state. But we cannot while to name ourselves independent power because losses have an effect on civil war, all is destroyed also the present government does everything to restore and modernize the state levers of authority.

In Tajikistan it is totaled more than **200 NGO**, which promotes the decision of the given problems under human rights, in particular children. On debate and seminars which carry out Children's Fund of the United Nations (**UNICEF**) the convention by the rights of the child has been accepted. There the role of the child is precisely and clearly underlined and its rights in our society are determined. If the uniform control system which will actively function and realize the ideas soon we shall receive positive results of activity of the state and, hence, a healthy society will be accepted.
